The National Democratic Institute (NDI) is organizing a House Democracy Partnership (HDP) exchange with its partners in Armenia, Georgia, Kenya, Liberia, North Macedonia, The Gambia, and Ukraine to discuss the importance of gender equality in parliaments. This program will also provide an opportunity for members of parliament (MPs) to engage in dialogue on methods to enhance gender mainstreaming in their legislative business and policy making. The program will focus on strategies to increase women's political participation in parliament, and to integrate gender into a parliament's structure and internal working procedures. This event will also focus on best practices for mainstreaming gender in parliamentary debate, and committee and congressional budget processes. Additionally, delegates will discuss strategies to ensure political decision-making space for women when national crises occur, and on how to engage in partnerships with men to continue advancing gender equality and gender mainstreaming in legislatures.

Women's Role in Consensus Building and Cross-Party Cooperation

Seeking alliances across party lines is crucial to getting gender issues on the agenda and to reform unequal legislative structures or policies. In this session, delegates will discuss the ways in which women MPs can work across party lines to advance shared priorities and support policies that positively affect women and other marginalized communities. For example, women's caucuses and multiparty working groups are effective ways to identify solutions to problems related to gender and to mainstream gender in legislation. This session will offer an outline of these initiatives, including their establishment, agenda-setting, and advocacy strategies.

Integrating Gender into Parliament's Structures and Operations

Gender mainstreaming within and across legislative institutions is critical to ensuring parity and inclusion at all levels. For example, it is not enough that parliaments engage women's participation through quotas alone. This must







be paired with efforts to integrate gender-sensitive policies and practices at all levels of a parliament's infrastructure and day-to-day working procedures. This will help ensure that long-standing inequities are not institutionally perpetuated and that transformative change is achieved. This session will present strategies to create more gender-sensitive parliaments, including incentivizing women's leadership in Parliament, creating infrastructure such as gender-focused committees and caucuses, establishing gender-related provisions in codes of conduct, and developing policies and procedures that improve gender equity and internal gender audits, and prevent discrimination and harassment.

Gender-Responsive Budgeting: Strategies and Best Practices

Gender-responsive budgeting is an important tool that incorporates gender analysis into the formulation and implementation of government budgets. Budgets that incorporate a gender lens ensure a more efficient and equitable use of national resources and address long standing inequalities. In this session, participants will discuss how to ensure spending is sufficient to meet the needs of all citizens, including women, to promote equal access to resources and services. This session will also analyze how budgets can

decrease the gender inequality gap by incorporating gender-specific expenditures that target women and girls and promote equal opportunities in the public sector. Finally, the session will provide strategies to ensure that budget formulation and implementation is informed by reliable, gender-disaggregated information.

Ensuring Space for Womens' Participation in Crisis Management

During times of crisis, recent events have proven that political systems risk moving from good practices in democratic governance to executive "command and control." In many countries, this shift can result in political decisions being made overwhelmingly by men. During the COVID-19 crisis in particular, women have faced additional challenges, including heightened economic vulnerabilities, augmented caregiving responsibilities, and increased gender-based violence. Breakout Rooms: Engaging Men to Advance Gender Equality in Parliaments
